New Year, Exciting Events!

The Management Council is planning exciting events for 2023. Here are the results of the member survey that will help us plan for the upcoming year:

- 59.5% of respondents would attend events regardless of location across the County
- 40% prefer interactive events, and another 37.3% want to incorporate networking in events
- Thursday and Friday polled as the most popular days to host events (getting 26.5% and 30.3% of the vote)

Updates to Management Resolution

Did your last paycheck look different? On December 13, the Board of Supervisors approved requested general and market-based salary adjustments for County employees classified as Management, Confidential Clerical and other Unrepresented Employees. The first took effect 12/25/2022 for 5.5% and will be followed by a 4% increase on 12/24/2023 and 3.5% increase on 12/22/2024.

This resolution also includes details on the California State Retention Bonus, Bilingual/Premium pay increases (for those who are eligible), the Flexible Benefit Allowance and new Medical Plan Opt-out option (for those who utilize that benefit). Details on the changes can be found in the <u>Board Letter</u> and in the updated <u>Management Resolution</u>.

CEO Dr. Sevet Johnson said, "We are pleased that in December 2022, the Board of Supervisors approved general salary increases, flexible benefits increases, and other amendments to the Management Resolution for our unrepresented employees. These align with the increases negotiated with SEIU for their represented employees and will help us to recruit and retain County Management employees within the current competitive job market."

Supervisor Gorell served as State Assemblyman from 2010 to 2014, served two tours of duty in Afghanistan, and is currently a Captain in the United States Navy Reserve.
